## FRAUDULENT INDUCEMENT CLAIM 1

Counsel Curtin claims that the amount of \$1,958.33/months for property taxes listed on the September 2020 statement is for the First Quarter of 2018 and covers Property Tax fees for three months not one, thus only \$652.77/month. Words "three "and "one" are emphasized by underlining. Motion to Dismiss 5:13-14; 5:27-28 Footnote <sup>5</sup>

According to Maricopa County Treasurer: Property Taxes in 2018 are: \$21,613.26/year or \$1,801.11/month

Thus, impossible to be \$652.77/month

The invoiced amount of Property Taxes on the September 2020 Statement to be paid by Plaintiffs is \$1,958.33.

Thus, three times the \$652.77 and is inflated by \$157.26/month or \$1,866.67/year

Robson and SRS defendants did not only lie about the real cost of Property Taxes in 2018, but additionally tried to extort from Plaintiffs \$157.26/month or \$1,886.67/year in unsubstantiated charges disguised as Property Tax.

# FRAUD IN FACTUM CLAIM 2

The altered/forged Lease the inserted without Plaintiff's knowledge clause requires of Plaintiffs to wait one year for TIA reimbursement, conditioned on Plaintiffs perfect performance.

July 02, 2020, and October 12, 2020, Scott Teerink refers to the clause as a basis to deny reimbursement of the TIA. It is a fact.
